All adoption fees and inspections must be PAID IN FULL before we can schedule vet appointments. We accept cashier's checks or paypal only. If you pay with Paypal, we will charge you a 4% administrative fee. No personal checks accepted. It will take at least 10 days to complete paperwork before your horse will be ready for shipping. Please plan accordingly. Our horses come from various areas of the U.S. and Canada. We are no longer doing the shipping for our adoptions due to health issues. You are welcome to come to the ranches to pick up your horse, or hire a reputable carrier. You can post on www.uship.com, but please check shipper's references.
